1. Outputs and impacts of education-related collaborations

My achievements in education showcase a remarkable blend of outputs and impacts resulting from my collaborative efforts. As Chief Investigator of the ARC Linkage Project "Innovative Financing Mechanisms for Higher Education" (2011-2015), I have significantly influenced the landscape of higher education policy in Australia and internationally. My work on higher education policy design includes the development of a dynamic model for student loan repayments in Australia, which has been referred to by a [submission](#) to the Review of Australia's Higher Education System and by policy papers on student loan design in [Australia](#), [Brazil](#), [China](#), [Indonesia](#), [Japan](#) and [Vietnam](#). In collaboration with Emeritus Professor Bruce Chapman, the architect of Australia's Higher Education Contribution Scheme (HECS), I established conditions for the design of income contingent student loans in Germany ([link](#)). In 2015, I developed a comprehensive [reform proposal](#) for higher education financing in Germany together with Christoph M. Schmidt, the top economic advisor to Angela Merkel. I have been involved in the organisation of major events, alongside esteemed scholars including three Nobel Laureates, underscoring leadership and impact within the academic community. My efforts to establish a global network of student loan scholars further reinforce my dedication to facilitating impactful research and dialogue in the field. These outputs and impacts reflect my commitment to advancing knowledge and driving meaningful change in higher education policy and practice.

2. Effective service for government education authorities

I have worked extensively with Federal education bodies to ensure education policy decisions are informed by scientific evidence. I have impacted understanding and policy development in several key areas through a series of commissioned reports (see research section). My efforts have highlighted significant disparities in lifetime earnings between men and women with equivalent educational qualifications. This insight has been instrumental in fostering policy discussions aimed at reducing gender-based economic inequalities and promoting policies that support equal economic opportunities. My work also guided discussions aimed at enhancing literacy standards and promoting lifelong learning initiatives. Moreover, it informed strategies for workforce integration and skill recognition, contributing to more inclusive labour market policies. Finally, my work influenced policy

discourse focused on improving job-skill matching, supporting career transitions and promoting continuous learning over the life cycle. The education policy-relevant evidence I produced was disseminated through presentations at Federal education bodies, including the Department of Education, Skills and Employment and the National Centre for Vocational Education Research.
